

Sir/Madam,

Reference is invited to your letter dated 05.06.2015 vide which a letter of intent and a fresh affidavit duly sworn in and another affidavit dated 22.09.2015 declaring that the university has closed down all study centres within and outside the state of Rajasthan have been forwarded to this office. UGC vide its letter nos. UGC/DEC/Jayoti/7437-7441 dated 04th June, 2015 had conveyed its approval to your University for offering programmes under distance learning mode during the session 2014-15. In this regard, I am directed to inform that the UGC vide its 505th meeting, vide item no. 2.03 held on 22nd December 2014 decided to maintain the status quo about recognition of the programmes, under distance education mode, during the academic session for 2015-16. Accordingly, the recognition accorded to your University, vide the above said letter of UGC, is hereby continued for the academic year 2015-16. Your University may therefore continue to offer the following programmes in ODL mode during 2015-16. The university is also directed not to offer any other programmes and send a compliance report to this effect.

2. Bachelor of Computer Application (B.C.A.)
3. Master of Computer Application (M.C.A.)
4. Master of Computer Application (Interegated)
5. Master of Commerce

2. The university shall scrupulously abide by the following terms and conditions, while offering the programmes through distance learning mode during the session 2015-16 in accordance with the Affidavit dated 04.06.2015 and dated 22.09.2015 duly notarised and signed by Deepti Rustagi, Registrar of the University, submitted to the commission vide letter dated 05.06.2015:-

- i) The University shall offer only those programmes through Open and Distance Learning (ODL) mode, which are approved by the statutory bodies of the University as per norms and also by UGC and wherever necessary by the apex regulatory bodies in the country.
- ii) It is the responsibility of the University to follow the norms prescribed by the concerned regulatory body/ies such as UGC, AICTE, NCTE/any other and also seek its/their prior approval, wherever required.
- iii) The University shall not start any new programme without prior approval of UGC and other concerned regulatory authorities in anticipation of recognition.
- iv) The nomenclature of all the programmes to be offered under distance mode shall be strictly as per UGC/AICTE Regulations.
- v) No teacher education programme shall be offered without prior approval of the NCTE.
- vi) The Ministry of HRD's directions prohibiting B.E/ B.Tech through distance mode vide it's letter dated 29.07.2009 shall be adhered to strictly.
- vii) The programmes in Engineering and Technology e.g. B.E/ B.Tech/ Diploma and courses in Medicines/ Nursing/ Physiotherapy etc. are not allowed and the University will not be offering the same.
- viii) The university shall refrain from offering such programmes that are not allowed to be offered, through distance mode by the respective apex body/ies.
- ix) No online programme leading to award of Degree/ Certification shall be offered by the University, until a policy is framed and approved by UGC in this regard.
- x) The minimum duration of a programme offered in ODL mode shall not be less than the minimum duration of similar programme offered through the regular mode.
- xi) The University shall run its ODL programmes only in those subjects/ fields which are offered by it through regular mode.
- xii) The university shall have at least one full time faculty member exclusively for coordinating each programme at the headquarters
- xiii) The eligibility conditions for admissions to each course to be offered through distance learning mode shall be as per norms of UGC/AICTE and other regulatory bodies.
- xiv) The territorial jurisdiction in respect of University for offering programmes through distance mode will be as per the policy of UGC on territorial jurisdiction and opening of off campuses/centres/study centres as mentioned in the UGC notification No.F.27-1/2012(CPP-II), dated 27th June 2013, a copy of which is also posted on the UGC website www.ugc.ac.in/deb.

3. Moreover, the University shall not offer any M.Phil/Ph.D Programme through distance learning mode in compliance to clause 5 of the UGC (Minimum Standard and Procedure for awards of M.Phil./Ph.D Degree), Regulation 2009. The University is advised to close down all the approved programmes and sent the compliance within 15 days.

4. The university's management of the distance education programmes will be open for review and inspection by the UGC. The academic norms of the programmes shall be under monitoring by the concerned regulatory authorities.

5. Your University is required to send, a list of the programmes that will be offered, through distance mode, during 2015-16, duly authenticated by the Registrar of the University.

6. It may also be noted that:

i) If the university fails to comply with the conditions of recognition for which the Affidavit, as mentioned above has been submitted or if it is found conducting affairs in a manner that leads to deterioration of academic standards, the UGC may withdraw its recognition.

ii) In case any information, documentary evidence submitted/produced by the University/institution is found to be false or fake at a later stage, the recognition of University/institution shall be withdrawn and the University/Institution concerned shall be solely responsible for the career consequences, if any arising out of the same.



Sir/Madam,

Reference is invited to Office letter no F.No.DEC/JV/Raj/10/6899 dated 02/09/2011 conveying the approval of the Distance Education council (DEC) to your Institution/University for offering programmes in ODL mode (copy enclosed). In this regard, I am directed to inform that the UGC has taken decision to maintain status quo for 2014-15 and accordingly the recognition/approval granted to you vide the aforementioned letter would continue for academic year 2014-15. Your Institution/University may offer the programmes in ODL mode which was approved by the statutory body of your University and were offered during 2013-14 in accordance with approval conveyed by DEC.

2 The above recognition is subject to the following terms and conditions:


- i) The University shall offer only those programmes through distance mode which are approved by the statutory bodies of the University as per norms and wherever necessary by the Apex regulatory bodies of the country.
- ii) It is the responsibility of the University/Institution to follow the norms prescribed by the concerned regulatory body/ies such as UGC/AICTE/any other, and also seek its/their prior approval, wherever required, for any specific programme mentioned above.
- iii) Nomenclature of all programmes shall be as per UGC/AICTE .
- iv) No teacher education programmes can be offered without prior approval of the NCTE.
- v) Programmes in physiotherapy are not allowed through distance mode.
- vi) University/Institution shall refrain from offering such programmes that are not allowed to be offered through distance mode by respective apex body/ies.
- vii) MHRD directions prohibiting B.E./ B.Tech through Distance mode vide its letter dated 29/07/2009 shall be adhered to strictly (copy at UGC website).
- viii) The eligibility conditions for admissions will be as per UGC/AICTE norms.
- ix) The minimum duration of a programme offered in ODL mode should not be less than the minimum duration of similar programme offered through the regular mode.
- x) The University has at least one full time faculty member exclusively for coordinating each programme at the headquarters.

- xi) The territorial jurisdiction in respect of Universities for offering programmes through distance mode will be as per the policy of UGC on territorial jurisdiction and opening of off campuses/centres/study centres as mentioned in the UGC notification No.F.27-1/2012(CPP-II), dated 27th June 2013, a copy of which is also posted in the UGC website www.ugc.ac.in/deb. In respect of standalone Institutions (other than the Universities), the territorial jurisdiction will be headquarters.
- xii) Franchising arrangement for offering programmes in distance mode in any form is not allowed.

3. The Institution's management of the distance education programmes will be open for review and inspection by the UGC. The academic norms of the programmes shall be under monitoring by the concerned regulatory authorities.

4. Before launching the programme/s, the Institution shall submit an affidavit within 30 days from date of issue of this letter that it agrees to and will abide by all terms and conditions contained in letter referred to in para 1 above and the terms and conditions laid down in para 2 above. In case the UGC does not receive the affidavit within 30 days from the date of issue of this letter, the approval accorded to your Institution will be liable to be withdrawn. It may also be noted that:

- i) If the institution fails to comply with the conditions of recognition or if it is found conducting affairs in a manner that leads to deterioration of academic standards, the UGC may withdraw its recognition.
- ii) In case any information, documentary evidence submitted/produced by the University/institution is found to be false or fake at a later stage, the recognition of University/institution shall be withdrawn and the University/Institution concerned shall be solely responsible for the career of the students enrolled.

5. Your university/institution is required to send along with the affidavit, a list of programmes (approved by the statutory bodies) that are on offer through distance mode currently, duly authenticated by the Registrar.

*The programmes are professional in nature, they require approval from the concerned Statutory Councils. Any other professional programme also requires approval from the concerned Statutory Councils. It will be the sole responsibility of your Institution to seek prior approval from the concerned statutory Councils/regulatory bodies, wherever required.

A. The recognition to above programmes is subject to the compliance of the following by the University.

- i. The University shall adopt curriculum and course materials of IGNOU or other DEC recognized ODL institutions for various programmes till such time it develops its proper SLM, **with extensive training to all concerned.** The University will follow all the structures and process of the various programmes including that of management programme of IGNOU including Credit values and evaluation procedures.
- ii. As the University is primarily for female learners, they must be given priority and encouragement by taking special measures if necessary.
- iii. The University should constitute an advisory board for the Directorate of Distance Education with outside experts in ODL system, and a representative of DEC as its member to guide the activities of the Directorate.
- iv. The University should follow the self learning methodology in updating, preparation of the course ware and should improve its existing course ware by involving more ODL experts on their programme expert committees representing subject related academicians from outside the university, from Rajasthan and other states, for preparing syllabi and developing, updating and revising the course materials as per ODL pedagogy.
- v. All Faculty and non teaching staff of Directorate of Distance Education should be Permanent and full time in nature.
- vi. The University should conduct intensive training programmes for the faculty and counselors for development of Self Learning Materials and other pedagogy with the support of STRIDE, IGNOU, and other schools of IGNOU and/or other bodies of similar caliber as per need, in consultation with the DEC. The University should revise its study materials on completion of this training programme.
- vii. The credit page should be included in the SLM at appropriate place by stating the names of experts who were involved in the material design, writing, editing team etc.
- viii. Involvement of external experts for setting paper, moderation and evaluation for term end examinations.
- ix. Additional recent references/ further readings should be included in the course materials.

x. The University should implement the Sixth Pay Commissions recommendations of the UGC and focus on the faculty development programmes and ensure that all faculty members should be either NET/SLET passed or Ph.D in relevant subjects.

B. The University/Institution may note that:

1. The Institution will offer only such programmes through distance mode which are offered by the Institution through regular face-to-face mode and approved by the Distance Education Council as mentioned in this letter. The Institution will not offer any other programme through distance mode other than those approved by the Distance Education Council.
2. Programmes, if any, in the areas of Health, Nursing, Dentistry, Management, Computers and allied areas may be offered with the approval of the statutory councils/regulatory bodies, wherever required.
3. It will be the responsibility of the Institution to follow the norms prescribed by the regulatory bodies, and seek their approval, wherever required.
4. The nomenclature of the programmes should be strictly as prescribed by the UGC/AICTE and approved by the Distance Education Council.
5. The eligibility conditions and duration of programmes will be as per the DEC norms and for professional and technical programmes as per the norms laid down by the AICTE. No admission to MBA, PGDBM and MCA programmes can be done without ensuring that that the student has secured a valid score in the entrance test examination for this purpose.
6. The Institution shall limit admission to maximum 60 seats per programme per Study Centre for Management, Computer & IT, and Allied Health Sciences programmes, if any. For laboratory/Practical work, the institution can have a maximum of 30 students in a batch subject to maximum 60 students per Study Centre. The Study Centre be owned by the University and should be opened with the approval of EC/BOM of the University concerned.
7. The Institution should have at least one full time faculty member exclusively for coordinating each programme at the Headquarters.
8. The territorial jurisdiction for offering programmes through distance mode will be as per the decision taken in the 35th Meeting of the Distance Education Council. In its 35th meeting the Council noted that distance education and online education cannot have the Territorial Jurisdiction. In case of Central Universities and the State Universities, the Territorial Jurisdiction will be as per their Acts and Statutes for offering programmes through distance mode. The Territorial Jurisdiction in case of Deemed Universities will be as per UGC, which mandates the prior approval of the UGC for opening Centres / off Campus Centres outside the Headquarters. The Territorial Jurisdiction in case of Private Institutions (other than Universities) will be as decided by the Joint Committee, which has decided that the territorial jurisdiction for the institutions (both private as well as Govt funded) shall be the Headquarters, and in no case outside the State.
9. The territorial jurisdiction for offering programmes through distance mode by your institution shall be the head quarters of the University as per the notification of the UGC and as per DEC norms.
10. The Distance Education Council prohibits franchising of Study Centres. Thus, your Institution will not franchise any Study Centre in any part of the country or abroad.
11. The Institution's management of the distance education programmes will be open for review and inspection from time to time by DEC to provide inputs for further improvement or as deemed necessary. The academic norms of the programmes shall be under monitoring and regulation by the concerned regulatory authorities.
12. For Management and Computer Science programmes, the Institution should also note that:
 - The programme should have a mandatory internship of six months;
 - Institute/University concerned should seek accreditation from National Board of Accreditation as per prevailing rules;
 - Institute/University concerned should have concerned Department and the conventional universities should have on campus programme on offer;
 - Institute/University concerned should not have advertised for the programmes before receiving the approval letter;

6. A candidate securing E grade in a subject shall be considered as backlog and has to clear the backlogs within the maximum duration of the course (Minimum duration of the Course + 3 years).
7. A candidate securing 'E' grade in a subject shall appear for both Continuous Assessment & End Term Examination as Backlog.
8. Absentee or Exam Cancellation Case will be treated as Backlog.
9. Final Year(s)/Semester(s)/ Trimester(s) Memorandum of Marks, will not be issued until previous backlog(s) are cleared, however the result will be declared.
10. In case of any error being detected in Memorandum of Marks and is brought to notice of the Examination Authorities, the University is fully empowered to correct the same.
11. **Grace Marks are applicable only for Academic Credits:** One Grace Mark each will be awarded, if required, in the fresh attempt in utmost two Theory Subjects on the aggregate marks obtained in that subject(s).

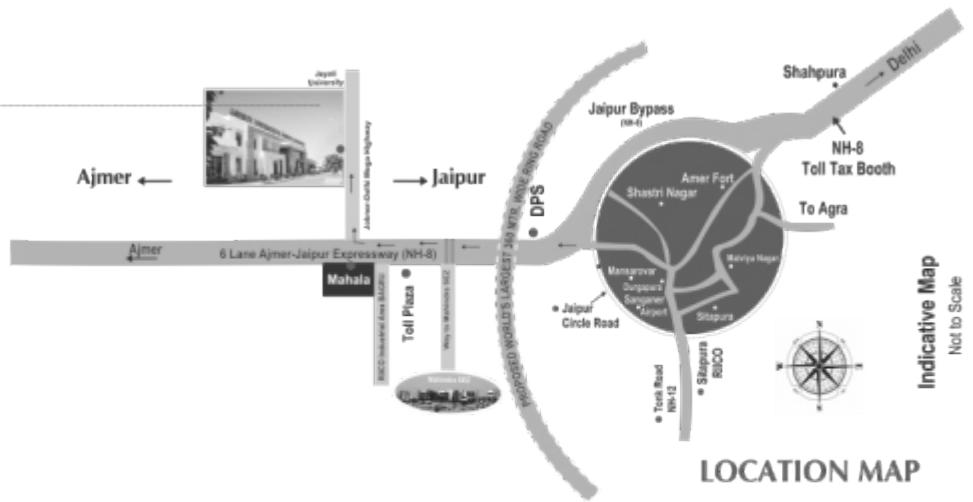
