At the outset, the Member Secretary, Ms. Meghna Singhal welcomed the Hon'ble Members of the Board of Management and took permission from Hon'ble Chairperson to begin the meeting.

Ms. Meghna Singhal, Member Secretary of the University extended a warm welcome to all the members of the Board of Management present in the meeting.

Resolved to confirm the minutes of 34th meeting of the Board of Management.

2. To inform and express profound grief on the sad demise of Late Dr. Panckaj Garg Member, Board of Management (Nominee of the Sponsoring Body) and Founder Advisor of the Jayoti Vidyapeeth Women's University

The Member Secretary BOM informed all the members of BOM about the sudden and sad demise of Late Founder & Advisor of Jayoti Vidyapeeth Women's University, Dr. Panckaj Garg on 6 June 2021, who was also an Honorable Member of the Board of Management (Nominee of the Sponsoring Body).

All the members expressed their deepest condolences and paid tribute to him by remembering his fond memories and the remarkable work done by him for women's higher education.

3. To filling up an casual vacancy on the post of Advisor of the University

All member were discussed about filling up of an casual vacancy of the post of Advisor of the University as per under section 27 of the University Act. After long deliberations, it was considered the recommendations of the all members of BOM and nominated Mr. Vedant Garg successor of Late Dr. Panckaj Garg (First Nominee of the Sponsoring Body) on the post of Advisor as he is eligible for the post of Advisor as per subsection (i) of section 29 of the University Act.

Thereafter, Mr. Suryansh Garg successor of Late Dr. Panckaj Garg (Second Nominee of the Sponsoring Body) will also be eligible for the post of Advisor after completing his minimum age of 18 years. And both of them will be the alternative nominees and will take appropriate decisions and action for fulfilling University objectives with mutual consent.

Hon'ble Chairperson (Ex-Officio) Ms. Vidushi Garg accepted the both nominations for the post of Advisor and approved the recommendation of BOM.

Further, it was resolved that, Mr. Vedant Garg's Appointment on the post of 'Advisor' of the University shall be in exercise of power conferred under Clause (f) of subsection (1) of section '29' of the University Act (17 of 2008) & section 20 and section 9 of part II Chapter -3 and section 26 of Part -V of the Chapter -4 the Statutes of the Jayoti Vidyapeeth Women's University Jaipur, 2010

It was also resolved that, he shall be appointed as a member of authority of the University on an emergent vacancy for only the remaining period of the member whose place he has appointed. thereafter, reappointment shall be done in accordance with University Act & Statutes.

All members considered and approved the agenda unanimously.

4. To filling up of an casual vacancy of Board of Management Nominee of the Sponsoring Body after sad demise of former Nominee of the Sponsoring Body.

Mr. Vedant Garg successor of Late Dr. Panckaj Garg (First Nominee of the Chairman, Jyoti Vidyapeeth Trust (Sponsoring Body of the University) as per the Clause 5 of Amended Jyoti Vidyapeeth Trust Deed dated 15 April 2019 was nominated by the sponsoring body for the filling up of an casual vacancy of Nominee of the Sponsoring Body- member BOM

Board of Management considered the recommendation of Sponsoring Body in accordance with Clause 5 of Amended Jyoti Vidyapeeth Trust and approved the agenda unanimously.

The Board of Management agreed to delegate all Rights & Powers in terms of academic administrative and financial powers of the Advisor to Mr. Vedant Garg so that he can discharge his all duties effectively for fulfilling all objectives of the University.


