- The Assessment of University Mission Course, University Compulsory Course/ Value Added Course, Community Development, Co-Curricular Activities & Extra- Curricular Activity Assessment will be based on Oral/Written/Practical/Presentation/Report Submission to be conducted four times in a year with a max weightage of 100 marks.

The following Recommendation of IQAC was proposed in the academic council which is unanimously considered by all the members.

- 10% -20 % enhancement in seed money amount for research work
- Increase share of granting aid
- consultancy and corporate training share increased up to 50 % with extra allowance.
- 50% fee share for quality paper publications and applications for patent filing by faculty members and students.
- Performance based assessment implemented with attractive benefits to potential faculty members. And Award of appreciation certificates, honors along with incentives for research work were implemented.
- Duty Leave and Travel Allowance to the faculty members for participating in international level Faculty Development programmes, Conferences, Workshop and Training etc.

5. To Consider the report of Directorate of Research & Development

Member Secretary placed the Annual Research Report before Academic Council. Members gave their satisfaction on overall research activities but pointed out the less submission of research projects for Grants by all Departments/Faculty.

- 3. In the year 2022-23, the University promoted the faculty members for indulging more and more into research which results in the successful publication of 33 patents in various fields and 50 + Quality paper publication in reputed journals.

All members and Academic Council considered the Research Report of the Academic Session 2022-23 approved the same,

6. To consider the status report of the University Board of Faculty, Departments, Directorates, and other units after abolition or restructuring of existing Department/ Board of Faculty & Directorates.

The Academic Council consider & approved the recommendation by Board of Faculty to dissolve The Faculty of Agriculture & Veterinary Science along with its infrastructure & all programs and Inclusion of Department of Food Bio Technology Faculty of Agriculture & Veterinary Science with its infrastructure & all programs and their inclusion in the Faculty of Education & Methodology so that students can be provided the maximum exposure of the learning resources by integrating the disciplines of Science, Technology & Education as per today scenario.

The Academic Council further considers the restructuring of the existing Department, 'Faculty of Education & Methodology.'

The members of the Academic Council considered the report and recommended it to the Board of Management for approval.

7. To consider and approve the recommendation of Finance Committee for the enhancement of Academic and Hostel Fee from the session 2023-24

The Academic council reviewed the recommendations of the finance committee, and it was resolved to increase the Academic fee min. @10% of demanding professional programmes from session2023-24 as recommended by the Finance committee. It was also resolved to revise the fee structure of hostel fee of some hostel rooms after renovation from session 2023-24. The enhancement of fee will be applicable only for the new admissions from session 2023-24 and onwards.

8. To consider the feedback report of stakeholders of the year 2022-23

Director Research Dr. Mini, informed all the members of Academic Council that, considering the feasibility of upgrading the curriculum, feedback survey among the major stakeholders like Students, Teachers, Alumni and Employers through blended mode Online/Offline. A Feedback Action Taken Report was also placed before the members which was considered and asked to upload on the official website of the university.

All members gave their approval to the feedback report of stakeholders and recommended to submit Action taken report in the next meeting of Academic Council.

9. To discuss and consider the amendments in Examination Rules/Regulations etc.

As per Recommendations of IQAC, for developing analytical understanding of the Course and for the successful evaluation of the earned credit question papers will includes a mix of objective (MCQs) and subjective questions (short answer, long answer questions and essay type questions) whichever is applicable and ensure that examination questions align with the learning outcomes of the course.

It was resolved that, Students will be given marks for their co-curricular, extra-curricular and CDA activities and without obtaining marks in such activities, students will not be allowed to appear in the end-term examination. UMC, UCC, CDA, ECA exams are conducted four times in a year with a max weightage of 25% marks each time.

It was also resolved that; Students must clear their all Backlogs to be eligible for Final Year End Term Examinations.

The Members considered all amendments to the Examination Rules and granted their approval.

10. To consider the degrees awarded by the University from 22 July 2022 to 19 July 2023 and to be proposed after completion of the credits and passing First to Final year.

All members considered and approved the same.

11. To consider the Academic calendar for session 2023-24

Academic Council discussed the various proposals for all kind of events to be conducted in Academic Year 2023-24.

Department wise proposed plan of Academic year 2023-24 for conduction of all Academic Activities such as Academic Tours, International /National Conferences, Webinar, Seminar, various Quiz, Debate, writing Competitions etc. and for other Celebrations, NSS, UBA, CDA activities placed before academic council.

The Academic Council suggested conducting more outreach programmes to promote experiential learning among students. The Academic Council also discussed granting academic relaxation to final year students who will be placed in the final semester and have internship/training/Dissertation in their final semester.

The Members gave their consent & considered the same.
