Seat Allocation Criteria

In pursuance of Clause 32, 31, 30 & 29 of Chapter- 5 of the "Statutes of **The Jayoti Vidyapeeth Women's University, Jaipur 2010**", the University Management has decided to upgrade the participation of girl's aspirants in Professional & Technical Programs from local area residing within 40 Km Radius of the University Campus.

University established in a rural area and there is no any other Professional College or University in surrounding area. To Encourage local girl's aspirants for higher education and to prevent dropouts, the University reserved the intake of seats in each program separately called as Local Seats with maximum possible subsidized fee structure as compared to general seats for local community so that maximum numbers of girls may get enrolled in professional & Technical Programs.

The allocation of seats are as per below mentioned Categories:


- A) Local Seats:** Local Seats are reserved for the Students who are resident within 40 Kms Radius of the University Campus, having domicile of Jaipur, Ajmer and Sikar District and appeared in any State level/University Level Entrance Examination/ Joint National Entrance Examination of the University.
- B) State Seats:** State level seats are reserved for the students who are resident of Rajasthan State, having the domicile of Rajasthan and appeared in any State level/University Level Entrance Examination/ Joint National Entrance Examination of the University.
- C) General Seats:** General Seats are applicable for students who are resident of India including Rajasthan State and appeared in any National level Entrance Examination/ Joint National Entrance Examination of the University.
- D) Management/ NRI Seats:** Management / NRI seats allotment shall be done as per directions of State Government / Government Of India.

However if any seat of reserved quota still remains vacant then such a seat shall be filled by the candidate who is in waiting list of Joint National Entrance Examination of the University.

A) Admission With Scholarship:

The aspirants who have applied for fee scholarship based University Entrance Examination- **Joint National Entrance Examination (JNEE-2018)** for BAMS, BHMS and BNYS programs need to submit their NEET Qualified Score card and JNEE score card on our **email ID- admission@jvwu.ac.in** before **30 June, 2018** to obtain admission with scholarship, based on JNEE score card as per mentioned below Grades.

JNEE Qualifying Grades:-

A Grade- 100-86 marks , B Grade- 85 -75 marks , C Grade- 74 - 55 marks , D Grade -54-50 marks , NG=No Grade

B) Admission Without Scholarship:

The aspirants who are seeking admission in BAMS, BHMS and BNYS programs without Fee scholarship, kindly send their NEET Qualified Score card on our **email ID- admission@jvwu.ac.in** before **30 June, 2018**.

C)* Admission Through Waiting Merit List: The aspirants who are seeking admission in BAMS, BHMS and BNYS programs through Waiting Merit List kindly send their NEET appearing Score card (mean Non Qualified Score Card) on our **email ID- admission@jvwu.ac.in** before **30 July, 2018**. **It is applicable if seats remains vacant and relate to the Government Policies.**

The Merit List & Waiting Merit List will be declared After 30 June, 2018 and the counseling date will be announced later.

The Procedure of counseling is not yet received from Government of India or State Government. Any modification may be included subject to the applicability.

Note: -Hostel Fee shall be applicable annually as per Room Category for every Academic Year.

-Hostel accommodation is mandatory for all students except who are permitted Day-Boardership.

-Day-Boardership shall be permitted only to the students who are resident within 40 Kms Radius of the University Campus and having domicile of Jaipur, Ajmer and Sikar Districts.

-10 % Seats are reserved for Day Boarders and 90 % seats for Residential Students.

Fee Payment Schedule:

- The Complete Program Fee shall be payable in a duration of **4.5 Years** with a yearly 4 Installments .
- The minimum Fee payable at the time of Seat Allotment as per mentioned below under fee heads :
Admission Fee + Development Fund + First Installment of the Tuition Fee & Hostel Fee.
- Remaining Fee Installments of complete Tuition Fee of the Program and Hostel Fee shall be payable in advance through **post-dated cheques** (PDC) in remaining 3 Installments.
- Once Fee has been deposited, will not be refundable in any case if the students has reported in the Campus.
- While taking Admission in the University, Students are advise to keep in their mind the prominent features of the university i.e., **Mobile Restricted Disciplined Environment, No Access to Social Networking Sites, Surveillance on Internet Usage and to obey all the Rules & Regulation framed by the University time to time.**





The Student may apply for the Management Quota /NRI Quota in all professional & Technical Programs offered by the University and the Merit shall be declared of Management/NRI Quota seats after main Merit List.


