- 4. The college has to develop the requisite infrastructure for IVth Professionals well in time as per the CCH norms which will be verified and reported by the CCH at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.
- 5. The college administration may take up the matter for recognition of the qualification under section 13(1) of the HCC Act, 1973 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
