Memorandum of Understanding Between

Jayoti Vidyapeeth Women's University Jaipur

And

Instituto Politécnico do Porto

This agreement is made this 11 day of December 2020 between InstitutoPolitécnico do Porto, a higher education institution legally formed under the Portuguese law, created by decree-law 513-T-29 and published in the Official Gazette n. 296 on 26th December 1979, located at Rua Dr. Roberto Frias, 712, 4200-465 Porto, Portugal (hereinafter Politécnico do Porto) and Jayoti Vidyapeeth Women's University Jaipur, established and incorporated under the Act 17 OF 2008 under section 2(f) & (12 b) of the UGC Act, 1956 located at Vedaant Gyan Valley, Village-Jharna, Mahala Jobner Link Road, NH-8 Jaipur Ajmer Express Way, Jaipur-303122, Rajasthan (INDIA) hereinafter.

In the spirit of mutual interest in cooperation, Politécnico do Porto and Jayoti Vidyapeeth Women's University Jaipur enter into this Memorandum of Understanding (MoU) to promote joint educational and cultural collaboration and agree as follows:

I: PURPOSE

- a) The purpose of this MoU is to promote and expand international understanding, development and friendship among the signatories by stimulating and supporting academic, professional and intercultural activities and projects directed at students, staff and faculty members of both institutions: Politécnico do Porto and the Jayoti Vidyapeeth Women's University Jaipur
- b) Because of the desirability of implementing activities outlined in this MoU in a systematic manner, Politécnico do Porto and the Jayoti Vidyapeeth Women's University Jaipur will generally coordinate any activities that may develop through their international relations offices. Faculty and staff members of each institution are expected to participate in the different projects developed under this MoU.
- c) This MoU presents and describes only the general aspects of the agreement with the understanding that designated personnel and offices of both institutions will negotiate supplemental agreements in written form for the development of programs or projects in specific areas of mutual interest, as well as any financial aspects of these that may arise.

- d) Some identified areas of activity of mutual interest and concern may include, but are not limited to, the following:
 - Student exchange programs
 - Faculty/staff exchange programs
 - Visiting scholar activities
 - Cooperative/collaborative research projects
 - Short-term training programs/projects
 - Cooperative and exchange lectures, conferences and seminars
- e) Students admitted for exchange shall remain enrolled and pay tuition and school fees to the University of origin and shall be exempt from payment of the normal fees and monthly payments in the Host Institutions, provided there is reciprocity in the number of mobilities in the respective school year. However, special fees can be paid at the destination University.

II: DURATION, TERMINATION AND DISPUTE RESOLUTION OF THE MoU

- a) This MoU will be effective from the date of signature and shall remain valid for an initial period of 2 (two) years. After this date, the renewal of this MoU shall be made in writing.
- b) Either institution may terminate this MoU through written notice signed by the chief administrative office of the notifying institution. The other party should receive the notice of termination at least 90 days in advance of the next academic semester. Termination would not affect students already engaged in any program derived from this agreement.
- c) The parties agree that any controversies, disputes or claims resulting from this MoU shall be first submitted to mediation. This shall be conducted in English. A mediated settlement, if any, shall be reduced to writing. If necessary, both parties will agree on a neutral arbitrator and agree to abide by its resolution.
