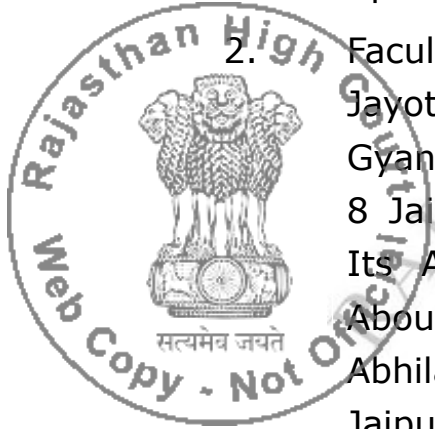

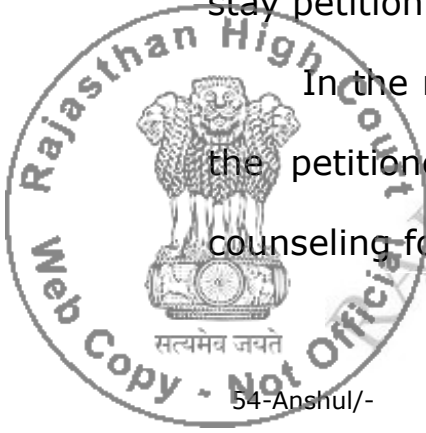
Heard.
