Introduction of Members

Director IQAC welcomed all the Members of IQAC and initiated the meeting .

Agenda 1. To confirm the minutes of previous meeting of IQAC .

The minutes of the 9TH IQAC meeting considered and Approved by the IQAC

Agenda 2. To inform and express profound grief on the sad demise of Late Dr. Panckaj Garg Member, IQAC and Advisor of the Jayoti Vidyapeeth Women's University.

The Member Secretary informed all the members about the sudden and sad demise of Late Founder & Advisor of Jayoti Vidyapeeth Women's University, Dr. Panckaj Garg on 6 June 2021, who was also an Honorable Member of the IQAC.

All the members expressed their deepest condolences and paid tribute to him by remembering his fond memories and the remarkable work done by him for women's higher education.

Agenda 3. To introduce new Hon'ble member of IQAC, Jv'n Vedant Garg who has been newly appointed on the post of Advisor & CEO of the University.

The IQAC welcomed Hon'ble member, IQAC Jv'n Vedant Garg who has been appointed as a member IQAC on an emergent vacancy.

It was resolved to approve the same.

Agenda 4. To Consider the Annual Report 2020-21

The Member Secretary presented Annual Report of Academic Session 2020-21 and briefly described the overall activities conducted by the Different Faculty/Units throughout a year through online/offline mode.

The members expressed happiness over the recent awards and honors received by the University in the year 2020-21 and expressed satisfaction at the research work done by the faculty members and students. Various initiatives taken by IQAC members towards international collaboration and MoUs were also appreciated in the meeting.

It was resolved to approve the same.

Agenda 5. To consider & inform about the status of NIRF Ranking 2021

The data submitted on February 10, 2021 for India Ranking 2021 in Pharmacy Discipline and Overall Discipline has been accepted by NIRF and further verification process is on.

Agenda 6. To discuss and plan the academic activities of session 20-21 including physical reporting of students at campus & To suggest various co-curricular activities to be organized in an academic year 2021-2022 in view of COVID pandemic

The IQAC discussed that, in view of the current pandemic situation, physical reporting of current students on campus is not yet possible, hence online classes will continue till the campus can physically open. It was also decided that after the lockdown, the students would report to the campus in 3-4 phases so that proper social distancing could be maintained in the campus during physical reporting.

University will also commence new session in the month of **September 2021** for fresher students and reporting of students can be completed through online portal.

It was resolved to approve the same.

Agenda 7. To Consider the research activities of the University of Session 2020-21 including status report of Research Paper Publications, Patent, Innovation & Incubation etc.

The Member Secretary presented report of Research activities and informed members that University's dedicated faculty members along with the research scholars applied and got their patents published in 2020-2021. In the year 2020-21 **35 patents** published by Indian Patents Office and 1 patent got awarded.

University's faculty members & Scholars got their research articles published in UGC listed/Scopus/Pub Med indexed/other online journals. In the year 2020-21 **Total 622** research papers published in various journals of repute.

Agenda 8. To consider the digital classes of Research course work and thesis submission of research scholars.

The Research Director presented the brief report about the course work of research scholars and their status of thesis submission. After gone through the report, the IQAC discussed to be designed 160 hours sessions for research scholars to provide e-lectures, library links and other study tools including face to face online problem-solving session on Google meet so that, Research course work can be started of newly enrolled research scholars in Jan 2021 whose course work is pending due to lockdown. Research scholars who could not submit their thesis for evaluation, Executive senate decided to felicitate them by submitting their pre-thesis/final thesis in soft copy. Further it was decided in the meeting that, Final Viva- Voce will also be conduct digitally through video conferencing.

All members considered the proposal, and it is resolved to approved the same.

Agenda 9. To inform about the status of NAAC Reassessment and IIQA to upgrade NAAC grading of the University.

The IQAC submitted the Institutional Information for Quality Assessment (IIQA) for the second cycle of NAAC reaccreditation on . The same was accepted by NAAC on with the direction to submit Self Study Report (SSR) within 45 days from the date of acceptance of IIQA. But unfortunately, due to complete lockdown and sad demises of Former Hon'ble member of IQAC and Advisor of the University IQAC couldn't submitted the SSR in stipulated time.

IQAC further decided to re apply for NAAC reaccreditation in next Academic Session.

It was resolved to approve the same.

Agenda 10. To consider the report of Intellectual Basket of Women National Conferences 2020 at university virtual base.

Even during the midst of COVID -19 Pandemic, the IQAC conducted online Intellectual Basket of Women National Conferences 2020.

The IQAC initiated steps to adopt the research Practices prescribed as per UGC to foster a research culture that emphasizes integrity in the daily practice of every student & research scholar.
