Jayoti Vidyapeeth Women's University, Jaipur, in strict compliance with UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 and Supreme Court directives, 2007 has decided to frame a Policy to Prohibit and Prevent Ragging Activities in its Campus. It is bound to take a stern view and adopt tough measures on students indulging in any or all forms of ragging. In the light of above, display of posters and putting up of notices on anti-ragging at all prominent places in and around the University highlighting the need for prevention of ragging and punishments entitled to those indulging in ragging. University has taken necessary steps for assuring peaceful life on the campus for new students and to prioritize the privileges of safeguards and safety of all students in general and the newcomers specifically. JVWU welcomes all the newcomers into its campus with an open and warm heart and shall endeavour to make their entry and stay into the sacred temple of learning as charming and successful as possible. JVWU pledges to Prohibit any incident of Ragging and does not hesitate to say 'No' to Ragging, Take Preventive Measures for occurrence of Ragging and establish Zero tolerance to Ragging and punish those who indulge in Ragging in the Campus as a cognizable offence.

- Prohibition of Ragging within or outside University campus is clearly mentioned in university prospectus, Reporting/ Joining forms.
- Affidavit for Anti-Ragging by students and parents must submit at the time of joining at university.
- Students are made aware of the Prohibition of Ragging through Poster, Sign Boards etc. which are mounted in Hostel Buildings and Academic Blocks.
- Anti Ragging Committee has been formed for regular monitoring and mentoring of students.
- Full CCTV surveillance in entire campus for close monitoring of students' activities
- Female Security Guards and Wardens are available in 24x7 each hostel.
- Counselling Centers are well developed in each hostel for continuous feedback and mentoring of students.
- The Initiatives of the University to curb the Menace of Ragging are as follows:
- Preparing and Distributing of Publicizing Materials such as posters, brochures, and circulars against ragging.

- Establishing Strong mentor mentee connect

Complaint Mechanism: Students can make a complaint through multiple channels online/offline mode to report grievances, via feedback portal, via email/letters, or in-person reporting to a trusted staff member.

Feedback Mechanism: Parents & Students can also give their valuable feedback online/offline through accessing University Information System (ERP) or by submitting Feedback forms available at reception/University website. There are separate panels for Parents & Student login. Username & Password will be provided to you after Enrolment.

For Student convenience, Students Complaint Box & Suggestion Box is placed at Communication Centre, where students can put their Complain/Suggestions with mentioning their name and Enrollment number.

Timely redressal of the grievances through appropriate committees:

- Grievance Redressal Mechanism is developed in the University to deal with individual grievances. We have adopted a model to deal with queries/complaints of students or their parents. Students or their guardians may contact University Officers for their queries. Parents/Guardians can call between university numbers during office hours and students may meet Officers after Academic Hours daily.
- **Internal Complaint Committee for Sexual Harassment:**

University is committed to provide educational environment, Free from Sexual Harassment, Unlawful persecution, Discrimination of any kind and working. University Redress Cell (URC) is established as per Vishakha guidelines to redress your grievances and to prohibit from Sexual Harassment (if any). The cell takes the cognizance of complaints reported on campus, Cell conduct enquiries, helps and reprisal to the victims, recommending penalties and act against defaulter. The complaints shall be curtailed by the cell within a period of seven days from the day of issue complaint registration number from Registrar Office.

- **Anti Ragging Committee:**
