Implementation of Academic and Administrative Audit

In the fifteenth year of its establishment, Jayoti Vidyapeeth Women's University focused more on quality enhancement in all the spheres of Academics. The University conducts External audit to ensure the effective use of available institutional resources. The audit was conducted by an independent three-member committee of external agency on the basis of Seven Criteria prescribed by NAAC as benchmark. The audit facilitates educational quality improvement practice, reviews the processes and procedures used by the University to enhance the quality of their programmes. Academic audit helps in a systematic way of reviewing the quality of education and it was aimed towards quality assurance and in bringing improvements in the education system of the University. Administrative audit ensures thorough evaluation of the administrative processes with respect to its efficiency, and effectiveness. The audit aims towards building and assessing policies, strategies, operations, and functions of the University.

Objectives of Academic and Administrative Audit

- The purpose of academic and administrative audit was to encourage all the academic, administrative, and other departments or programs to evaluate their process and working pattern.
- In Academic departments the objective was to enhance and check the “education quality processes” which is the key factor required to produce, assure, and regularly improve the quality of teaching and learning.
- The purpose of an external academic audit was to provide an objective independent examination and to verify that the documents and working style of various departments provide a true and fair reflection of where the University stands.
- To bring new academic reforms and keep track of the progress, and support reforms of the University
