At the outset, the convener welcomes all the members present in the meeting.

**Agenda 1. To discuss and form the courses & their curricula for study & research considering the text books, supplementary reading, reference books and other learning material leading to Women Empowerment through creating more learning opportunities for Women.**

The members discussed about the formation of new courses in the category of management giving the practical knowledge in relation to Industry needs.

Further BOS members discussed the proposal to introduce new course BBA -Retail Management. The Convener introduced the proposal to introduce a **BBA Retail On-Job Training Course (3 years)** in collaboration with the Retailers Association's Skill Council of India (RASCI) External member Ms. Heena from RASCI informed that, the objective of this program is to equip students with industry-relevant skills, hands-on training, and direct exposure to the retail sector. The members acknowledged the growing demand for skilled professionals in the retail industry and expressed their support for the initiative.

BOS members discussed that, the course will follow a **three-year structure**, integrating theoretical learning with practical on-the-job training in collaboration with retail industry partners. The eligibility criteria were discussed, and it was agreed that students who have completed their **10+2 (any stream)** will be eligible for admission.

The assessment methodology will include **continuous evaluation, internships, industry projects, and final examinations**. Course curriculum will be covered theoretically on campus and practically at industry training partner.

BOS members applauded on obtaining approval from UGC for B.VOC programmes and defined the primary objectives of these courses as follows:

- Enhancing employability by providing skill-based education.
- Aligning with industry requirements for trained professionals in the banking and financial sector.
- Offering multiple entry and exit options as per NSQF levels.
- Integrating theoretical knowledge with practical and on-the-job training.

The members deliberated on the feasibility, industry partnerships, and course structure and agreed to proceed with the proposal, subject to further curriculum development.

The members discussed the need for faculty training programs to align with industry standards. The Chairperson thanked all members for their valuable inputs and participation.

The members discussed the need for faculty training programs to align with industry standards.

A proposal was made to conduct an **annual industry-academia meet** to strengthen the partnership with the retail and banking sectors.

The meeting concluded with appreciation for the efforts made towards introducing these industry-integrated courses.

The Convener thanked all the members of the Board of studies and proposed a vote of thanks which was applauded by all the members.
