

The LLM curriculum and syllabi of 1 to 4 sem was presented by Ms. Tanushi Sahni . The members had thorough discussion and suggested the following points

Branches were named as – LLM (Criminal Law) , LLM (Business Law) .

2 LLM can be classified into various branches –

- Constitutional
- Administrative
- Human Rights
- Criminal
- Business
- Feminist Order

Dr Archana Madam gave her additional suggestion that these subjects can also be taught in the 4 semesters of LLM .

- Law and Social Transformation In India
- Indian Constitutional Law : New Challenges
- Judicial Process
- Legal Education and Research Methodology

Students must get Practical exposure and knowledge about the following topics –

- Comparative Criminal Procedure
- Drug Addiction
- Juvenile Delinquency
- Collective Violence and Criminal Justice System

In their last Semester – 4 Sem , Student must also pursue Project Report and Internship

Both the experts were satisfied with the outlines. Dr Tariq also quoted that he would share his views , if required in future as well .
