Agenda 1. Confirmation of Minutes of the last meeting of the Board of Studies.
The members of BOS confirmed and approved the meeting minutes of last Board of Studies

Agenda 2. To Approve the new structure for courses starting from Academic Session 2019-20 as per AICTE guidelines.

External members of BoS suggested that emerging skill-oriented course components should be added in the syllabus of B. Tech students and should be introduced from the first year B-Tech course curriculum. Different core subjects were reviewed, and their amendments proposed by the experts keeping in mind the AICTE curriculum.

Agenda 3. To Discusses the changes required in BOS for discarding courses which are not viable and bring the necessary changes for implementing the curriculum.

The BOS reviewed the remarks of NAAC peer team considers the feedback received from stakeholders who include students, parents, alumni, industry experts etc. related to upgradation to be brought into curriculum in various programs. The BOS keeps track of the emerging trends and latest industry requirement, the global changes taking place in relation to the innovativeness etc. and bring in the necessary changes into curriculum so that the curriculum is up to date addressing all current requirements.

Agenda 4. To consider the amendments in curricula of courses on the basis of feedback of Stakeholders.
The Board of Studies discussed to form soft skill training & technical skills based courses because certain domain specialization courses need to be form beyond text material & readings can include articles, journals etc. that further illustrate applications or offer alternative valuable resources which will be helpful for hands on practice

It Resolved to approve the same.

Agenda 5. To introduce new Electives for B.Tech-2019-20

The Board of members who are present in the meeting gave their suggestions about the scope of opportunities for students pursuing engineering degree. They have mentioned the need for more application-oriented course to be introduced because IT sector, has the potential to create employment opportunities for a huge section of educated women.

It is further discussed among members that use of new technology, creative activities seemed to have been important sources to take up large segment of engineering exclusively for women with the hope of getting more jobs and having a successful career for them.
